### Data Protection Notice for the 2<sup>nd</sup> WomenINvestEU Networking Event

**Your personal data** is processed in accordance with Regulation (EU) No 2018/1725<sup>1</sup> on the protection of individuals with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data.

**The data controller** of the processing operation is Unit I.02 of the European Innovation Council and SMEs Executive Agency (EISMEA) who can be reached via [EISMEA-SMP-GENDER-INVESTORS@ec.europa.eu](mailto:EISMEA-SMP-GENDER-INVESTORS@ec.europa.eu).

The following **entities process** your personal data on our behalf: EurA AG (Max-Eyth-Straße 2, 73479 Ellwangen, Germany) – [womeninvesteu@eura-ag.de](mailto:womeninvesteu@eura-ag.de), Business Angels Europe (Kunstlaan 6, 1210 Brussel, Belgium) and its subcontractor META Group s.r.l. (Via Francesco Mancini, 23, Terni, Italy), Bpifrance (Avenue du Général Leclerc 27-31, 94710 Maisons-Alfort, France), as selected contractors for the implementation of the WomenINvestEU project, and the approved third-party authorised sub-processor: Zoom and Cognito Forms (for the purpose of hosting and managing web meetings).

**The legal basis** for the processing activities is/are:

- Article 5(1)(a) of Regulation (EU) 2018/1725 because processing is necessary for the performance of a **task carried out in the public interest** (or in the exercise of official authority vested in the Union institution or body)<sup>2</sup> laid down in Union law;
- Article 5(1)(d) of Regulation (EU) 2018/1725 based on **your explicit prior consent** for your non-mandatory personal data indicated below; - etc.].

**The purpose(s)** of this processing is to:

- collect your registration for the 2nd WomenINvestEU Networking Event and follow up through a satisfaction survey;
- provide you with access to the online event platform (Zoom);

**The following of your personal data are collected:** your first name, last name, email address, organisation and job position. All personal data are **mandatory** for the purpose(s) outlined above.

**The recipients** of your personal data will be the EISMEA and Commission staff in charge of the WomenINvestEU project and bodies in charge of monitoring or inspection tasks in application of Union or national law (e.g. internal audits, Court of Auditors, European Anti-fraud Office (OLAF), law enforcement bodies).

Some of your personal data **might be transferred** to third countries or international organisations as follows:

- Personal data may be transferred from the EEA to third countries outside of the EEA using Standard Contractual Clauses (SCC, also known as EU model clauses) adopted by the European Commission. These SCC contractually ensure a high level of protection. Zoom implemented the new SCCs in 2021 into Zoom's standard DPA. Zoom has incorporated the new SCCs into applicable agreements following the transition periods specified by the European Commission. The event will be conducted **using the following tools:**

- For the purpose of hosting web meetings, **Zoom**, third-party tool under the data controller's responsibility, collects data when the registers and enters the session. It collects name and email address.

- For the purpose of collecting registrations for the event, **Cognito Forms**, third-party tool under the data controller's responsibility, collects data when the users submits a form to schedule bilateral meetings with the attending EIC Partners. It collects name, email address and organisation, provided that the users submit it through the form.

The processing of your data will **not include automated decision-making** (such as profiling).

**The following technical and organisational security measures** are in place to safeguard the processing of you personal data:

- All personal data in electronic format (e-mails, documents, databases, uploaded batches of data, etc.) are stored on the servers of EISMEA, the European Commission and of its contractors and subcontractors, engaged to assist the controller in the implementation of the project's activities;

- All processing operations are carried out pursuant to Commission Decision (EU, Euratom) 2017/46 of 10 January 2017 on the security of communication and information systems in the European Commission;

- In order to protect your personal data, EISMEA and the Commission has put in place a number of technical and organisational measures. Technical measures include appropriate actions to address online security, risk of data loss, alteration of data or unauthorised access, taking into consideration the risk presented by the processing and the nature of the personal data being processed. Organisational measures include restricting access to the personal data solely to authorised persons with a legitimate need to know for the purposes of given processing operations.

- EISMEA and Commission contractors and subcontractors are bound by specific contractual clauses for any processing operations of your personal data on their behalf and by the confidentiality obligations deriving from the General Data Protection Regulation ('GDPR' - Regulation (EU) 2016/679)

**Your personal data** will be kept for a maximum period of 2 years from 26/06/2025. Data will be manually deleted at the end of this period.

The personal data may be further processed for historical, statistical or scientific purposes. The further retention time for this purpose will be up to 20 years.

**You have the right** to access your personal data and to request your personal data to be rectified, if the data is inaccurate or incomplete; where applicable, you have the right to request restriction or to object to processing, to request a copy or erasure of your personal data held by the data controller. If processing is based on your consent, you have the right to withdraw your consent at any time, without affecting the lawfulness of the processing based on your consent before its withdrawal.

Your request to exercise one of the above rights will be dealt with without undue delay and within **one month**.

Your right to information, access, rectification, erasure, restriction or objection to processing, communication of a personal data breach or confidentiality of electronic communications may be restricted only under certain specific conditions as set out in the **applicable Restriction Decision** in accordance with Article 25 of Regulation (EU) 2018/1725.
